



## CLASS & EXAM SCHEDULE

April 20, 2022, update

1. **Classes** are scheduled to take place live in Kraków unless otherwise stated below. Classes will be on the dates below at **17:30-20:00 Kraków time** whether live or online. If border restrictions, relevant university policies, or the professor's situation regarding travel require a course to be moved online, students will be informed prior to the course, but that decision may come relatively close to the courses' first meeting.
